ABSTRACT:

This roundtable, organized by the CEIPI and the CPVO in context of the CEIPI Series of lectures, aims to gather institutional and academic specialists in plant variety rights in order to discuss the current state and perspectives of the system of community protection provided to this peculiar form of intellectual property protection (Community plant variety (CPV)). Established following the UPOV 1991 Act as a unified community title within the European common market in 1995 (Council Regulation (EC) No 2100/94 of 27 July 1994 on Community plant variety rights (OJ L 227 of 01.09.94 p.1)), it is managed by the Community Plant Variety Office (CPVO), located in Angers. The latter's mission statement is as follows: "To foster innovation in plant varieties by high quality processing of applications for Community plant variety rights at affordable costs while providing policy guidance and assistance in the exercise of these rights for the benefit of stakeholders" (Strategic Plan 2010-2015). During the roundtable, speakers will touch upon such crucial issues as the role of CPV to foster innovation, the purpose and mission of CPVO within the community IP system, its Board of Appeal current case law, the ethical ques involved with plant variety rights (especially in the context of food security), as well as the interface between CPV and patents.
