The BTC Prague is organized in cooperation with the Industrial Property Office of the Czech Republic.

The courses will take place at the Czech Industrial Property Office (UPV), from October 11th 2021 to June 21st 2022.

(Please note that a minimum of 6 participants is needed to open the course.)

The Basic Training Course in European Patent Law in Prague is organized in one intensive year (with about 120 hours per 2 semesters), starting in autumn 2021.

The basic training provides future practitioners in the patent field with systematic and complete tuition on **the legal basis** as well as on **practice** in the area of European patent law. For many years now, **CEIPI** and **epi** have been jointly organizing a basic training in European patent law, principally aimed at future certified European Patent Attorneys.

The basic training is designed both to facilitate preparation for the European Qualifying Examination and to **accompany the practice of the profession**: future practitioners should commence the course as soon as possible after joining a patent firm or the patent department of a company.

Usually, about 350 participants follow this course every year offered simultaneously in the following cities: Aachen, Antwerp, Basel, Barcelona, Berlin, Brussels, Bucharest, Budapest, Cologne, Copenhagen, Darmstadt, Dublin, Düsseldorf, Hanover, The Hague, Helsinki, Istanbul, Kraków, Lausanne, Lisbon, Ljubljana, London, Ludwigshafen, Lyon, Madrid, Manchester, Milan, Munich, Paris, Prague, Riga, Rome, Stockholm, Stuttgart, Ulm, Warsaw, Vienna, Vilnius, Zurich.
