

<p><b>Title of the training</b></p> <p>"Correction of paper" for paper C of the EQE</p>
<p><b>Public</b></p> <p>The training is intended for people taking Paper C of the EQE. To register for this paper with the EPO, candidates must meet the EPO's requirements (see the new EEQ regulations, OJ EPO 2024, A4).</p>
<p><b>Prerequisites</b></p> <p>Participation in this non-degree training course does not require any specific prerequisites with regard to the target audience.</p>
<p><b>Entrance requirements</b></p> <p>This is a non-degree professional training course. Candidates should preferably have attended a CEIPI course preparing for the EQE Paper C or a similar training.</p> <p>Admission upon validation of the application file.</p>
<p><b>Objectives</b></p> <ul style="list-style-type: none"> <li>- Help candidates to develop, improve and train examination skills by passing a mock examination paper under exam conditions and receiving a detailed correction of their paper by a CEIPI tutor, as well as the CEIPI model solution for this paper</li> <li>- Help candidates to evaluate their current level of knowledge and skills in order to better adapt their remaining exam preparation and the choice of further training courses.</li> </ul>
<p><b>Program / Content</b></p> <ul style="list-style-type: none"> <li>- Participants write a mock paper C at a date of their choice during the academic year and provide the paper to the CEIPI.</li> <li>- A CEIPI tutor corrects the candidate's paper and returns it with a personalized feedback and the CEIPI model solution to the paper.</li> </ul> <p><b>Duration</b></p> <p>7 hours (6 hours of mock examination under exam conditions and one hour of correction of the paper by a CEIPI tutor)</p> <p><b>Schedule (for information purposes)</b></p> <p>According to the above duration at one of the suggested dates during the academic year</p> <p><b>Tutors</b></p> <p>The tutors for this module are either professional representatives (from private practice and industry) or staff of the departments of first instance of the EPO and of the Boards of Appeal. All have extensive knowledge and practical experience in the procedures before the EPO, be it in examination and opposition, or in appeal before the Boards of Appeal.</p>
<p><b>Teaching methods</b></p> <ul style="list-style-type: none"> <li>- Mock examination: participants sit a mock paper C under exam conditions</li> <li>- Individual correction of the participant's paper by a tutor in the light of the model solution suggested by CEIPI</li> <li>- Return of the corrected paper to the participant accompanied by recommendations for the further EQE preparation</li> </ul> <p><b>Training material</b></p> <ul style="list-style-type: none"> <li>- Paper C 2019</li> <li>- Corrected paper and corresponding model solution as suggested by CEIPI</li> </ul>
<p><b>Validation</b></p> <ul style="list-style-type: none"> <li>- The training aims at the adaptation and development of skills. Participants will receive an attendance certificate.</li> <li>- An evaluation questionnaire will be submitted to the participant to measure client satisfaction.</li> </ul>
<p><b>Location</b></p> <p>Distance learning. Communication via email.</p>
