



Preface

The Center for International Intellectual Property Studies (CEIPI) Diploma on Patent Litigation in Europe is a training program crafted for patent professionals willing to deepen and update their knowledge in comparative and regional patent law and patent litigation.

International and European in contents, speakers and participants, the CEIPI diploma provides a hands-on immersion in the systemic aspects of patent litigation and the most recent patent litigation practices.

The CEIPI Diploma on Patent Litigation in Europe falls within the wider offer of CEIPI

in the area of intellectual property enforcement, a plurality of programs targeting judges, patent attorneys, attorneys at law, public servants and other qualified professionals in the intellectual property domain. In this case, the training program is addressed to European Patent Attorneys willing to become European Patent Litigators, attorneys at law and other experienced intellectual property professionals willing to gain knowledge and update their experience in European patent litigation.

Set up in the early 2000', the CEIPI Diploma provides a truly European and international perspective on patent adjudication theory and practice, leading to the obtention of a Diploma of the University of Strasbourg.

In 21 editions of the CEIPI Diploma on Patent Litigation in Europe, more than 1500 people have been trained in Strasbourg.

Concept of the studies

The CEIPI Diploma on Patent Litigation in Europe is a professional training program intended at satisfying the need of update and refinement of the knowledge in patent litigation.

The program allows participants to go through the practice in the European jurisdictions attracting most of patent litigation, and put on the unitary patent and the Unified Patent Court.

Patent litigation touching infringement and validity is at the core of the Diploma, but the program goes beyond interconnected and addresses other relevant

subjects. This is notably the case of competition law, alternative dispute resolution and private international law. Other related intellectual property titles, notably supplementary protection certificates, are also the object of interest. The goal is to present both traditional topics of relevance in patent litigation, such as remedies and damages, as well as contextual aspects impacting actual patent litigation.

The program has been adjusted as to satisfy the requirements of the European Patent Litigators Certificate, approved by the Administrative Committee of the Unified Patent Court, thus it will be of particular interest to those European Patent Attorneys willing to become European Patent Litigators.

Methodology

The large majority of speakers are judges and patent litigators with vast experience in patent litigation. Moreover, classroom lectures are combined with an intense analysis of jurisprudence and practical exercises, including workshops with case studies and a mock trial. The latter occupies two days of the program and also involves team-work in the preceding modules.

Reference documents are progressively made available online and participants are expected to check them and prepare the content of each module beforehand.

When on-site, teaching will be imparted in the CEIPI premises in Strasbourg. Otherwise, courses will be delivered online.

Participants

Participants to the course can be:

- → European Patent Attorneys with practice before the EPO Boards of Appeal and/or national patent litigation courts (as representatives of parties, private or court appointed experts or judges).
- \rightarrow Attorneys at Law with proven knowledge and experience in patent law.
- → Those who do not fulfill these conditions may still be accepted upon a proven record of expertise in the area of patent drafting and practice.
