# Master 2 Intellectual Property Law and Management

#### **Public concerned**

The Master 2 Intellectual Property Law and Management program is offered as a continuing education program and is aimed at professionals who wish to diversify their core business of acquiring intellectual property rights (patents, trademarks, designs, and models) and managing intellectual property portfolios. The program also aims to provide business leaders with the intellectual property management skills that their previous studies may have lacked.

## **Prerequisites**

Only candidates with a Master's degree in science, private law, economics, or management may be admitted to this specialty. The program is open to authorized representatives of the European Patent Office or national offices, industry specialists, lawyers, and experts specializing in this sector. All candidates must have at least three years of professional experience in intellectual property law.

They must also demonstrate a good command of English.

Foreign students, whether or not they are nationals of the European Union, must meet the same requirements as those listed above.

### Access conditions / Admission procedure

Candidates must complete an online pre-registration form. Admission to this program is based on an application reviewed by the diploma's teaching committee.

## **Teaching objectives**

The teaching objectives are as follows:

- Mastering industrial property rights for the various professions that intersect with business management and strategy.
- Providing business executives with fundamental knowledge in the fields of industrial property management, the implementation of new technologies, technology management, innovation management, innovation financing, intellectual property rights securitization, etc.

Students will gain an understanding of business strategies and markets. They will identify the economic environment and influencing factors, and master the development of strategies based on intellectual property rights business.

The objective is to train high-level specialists in intellectual property rights management, capable of understanding:

- research and development, study, and design functions,
- methods and industrialization functions,
- industrial property and standardization functions,
- evaluation and valuation of intangible assets.
